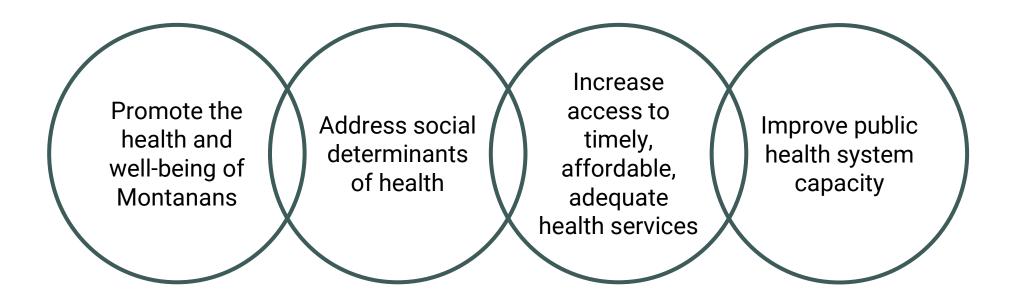

Epidemiology and Scientific Support

Conducts disease surveillance and control for infectious disease Provides infection control and prevention expertise to health care facilities

Maintains several core public health surveillance systems

Leads efforts to modernize public health data systems

Assists with investigating reports of infectious conditions, outbreaks, and novel events

Implements activities to increase blood lead screening

Conducts infection prevention and control assessments

Works to reduce, eliminate, and prevent exposures to toxic substances

Works with health care facilities and local and tribal public health agencies to implement proper treatment and infection control practices



Public Health System Improvement Office

- Provides funding and technical assistance to state, local, and tribal public health departments to improve health department operations, community health improvement planning, workforce development, and performance management;
- Implements and monitors the public health system improvement plan and the public health workforce development plan;
- Works with the National Public Health Accreditation Board to promote and assist health departments in achieving National Public Health Accreditation.

Financial Operations and Support Services

- The Financial Operations and Support Services Bureau (FOSSB) provides financial and contract management for PHSD and oversees the Office of Vital Records (OVR).
- The OVR maintains vital event registration and reporting for all Montana counties.

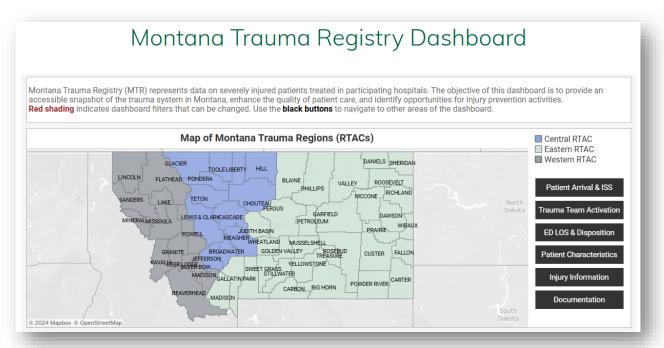

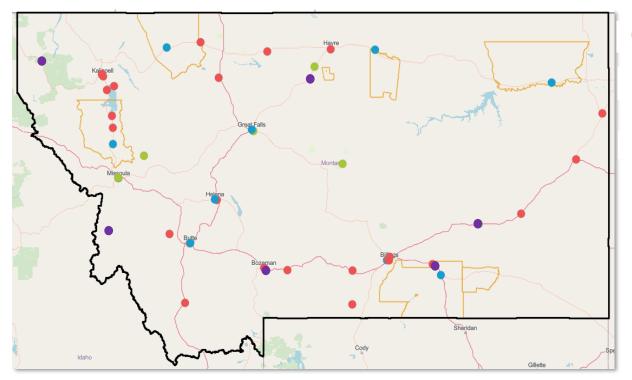

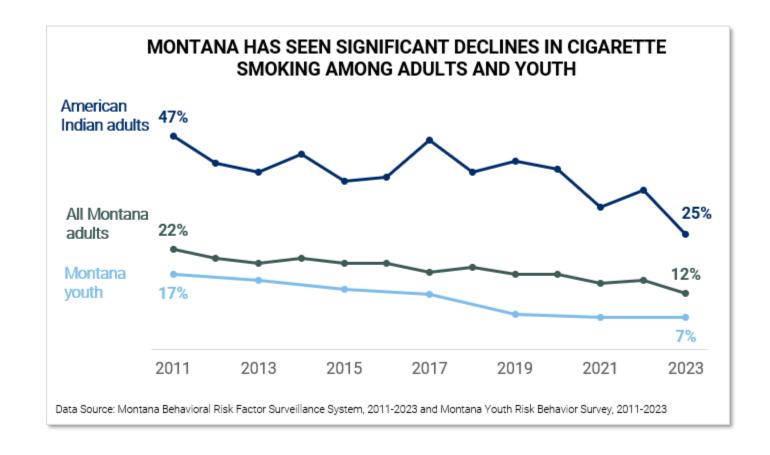
Montana Diabetes Program: Increased Access to Self-Management Education and Support Services

- Six additional Diabetes Self-Management Education and Support (DSMES) Programs have been added since 2022.

 Forsyth, Hardin, Hamilton,
 and Libby
- The Montana Diabetes Program (MDP) accomplished this through the implementation of the Montana Diabetes Education Accreditation Program (MT DEAP), to support the capacity building that often challenges DSMES sites from forming and receiving reimbursement.

Modernization of Public Health Data Infrastructure

Siloed, outdated data infrastructure unable to keep pace with volume and needs

\$13.3 million Federal cooperative agreements

- Automate clinical and laboratory reporting
- Exchange data between states
- Ensure interoperability among core public health data systems
- Upgrade systems with modern technology



Responding to Infectious Disease Outbreaks



From January 2023 through October 2024, 299 infectious disease outbreaks were reported to public health, two-and-one-half times greater than the 80 outbreaks reported from 2021 to 2022.



A 2024 outbreak of Shiga toxinproducing *E. coli* (STEC) caused by the consumption of ground beef served at several Montana restaurants sickened 23 people from 11 states, including nine hospitalizations and one death.



In 2023, two outbreaks of group A *Streptococcus* among residents living in long-term health care facilities sickened 14 people, including three deaths.

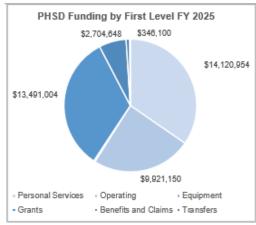

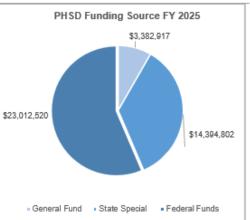

Change Packages – Present Law (PL) Adjustments

SWPL 1 - PERSONAL SERVICES

The budget includes a reduction of \$171,704 in FY 2026 and \$143,883 in FY 2027 to annualize various personal services costs including FY 2025 statewide pay plan, benefit rate adjustments, longevity adjustments related to incumbents in each position at the time of the snapshot, and vacancy savings.

SWPL 3 – INFLATION DEFLATION

This change package includes a reduction of \$2,378 in FY 2026 and \$1,607 in FY 2027 to reflect budgetary changes generated from the application of deflation to state motor pool accounts.

Change Packages - New Proposals (NP) Adjustments

NP 7001 - REALIGN APPROPRIATION FOR RYAN WHITE ADAP

This new proposal reduces the appropriation of federal funds for the Ryan White ADAP Shortfall fund to align appropriation with anticipated expenditures. This change package requests a reduction of \$1,410,205 in federal funds over the biennium.
