

Montana Section 1115 Waiver for Additional Services and Populations (WASP) Demonstration Waiver

June 2022 Extension/Renewal Submission

Effective Date: January 1, 2023

TEXT OF NEWSPAPER PUBLIC NOTICE

On or before June 30, 2022, the Montana Department of Public Health Human Services (DPHHS) will submit a 5-year Section 1115 Waiver for Additional Services and Populations (WASP) Medicaid Waiver Extension/Renewal application for approval to the Centers for Medicare & Medicaid Services (CMS) with a proposed effective date of January 1, 2023 and extending through December 31, 2027. The waiver extension/renewal makes no substantial changes. The current waiver includes two populations:

As of year-end 2021, approximately 1,100 individuals age 18 or older, with Severe Disabling Mental Illness (SDMI) who were otherwise ineligible for Medicaid benefits and either:

- Had income 0-138% of the Federal Poverty Level (FPL) and are eligible for or enrolled in Medicare; or
- Had income 139-150% of the FPL regardless of Medicare status (they can be covered or not covered by Medicare and be eligible).

Approximately 29,300 individuals were determined categorically eligible for Aged, Blind and/or Disabled (ABD) dental treatment services above the \$1,125 State Plan dental treatment cap.

The goal of the WASP Demonstration mirrors the state's Medicaid goal, that is to assure medically necessary medical care is available to all eligible Montanans within available funding resources.

The goal of WASP for the Mental Health Services Plan (MHSP) population is threefold. The goals include improving:

- (1) access to mental health care,
- (2) utilization of mental health care, and
- (3) mental health outcomes for individuals age 18 or older, with Severe Disabling Mental Illnesses (SDMI) who qualify for, or are enrolled in, the Section 1115 WASP (WASP) by providing coverage to receive Standard Medicaid benefits for mental health services.

The estimated total annual fiscal benefit impact is \$0.00.

The goal of including the ABD Dental population in the WASP coverage is to provide individuals determined categorically eligible for ABD with dental treatment services above the \$1,125 State Plan dental treatment cap. The estimated total annual fiscal benefit impact is \$0.00.

To provide transparency in the state's proposed application for the 5-year Section 1115 WASP Medicaid Waiver Extension/Renewal application, there will be public hearings and a public comment period.
