Surveillance and Evaluation

Courtney Geary provided a brief report on Surveillance and Evaluation and spoke about what she does for the Asthma Control Program in her position as the Epidemiologist/Evaluator. This included Healthcare QI evaluation reports, future evaluations such as ASME reimbursement through Medicaid among certified MAP home visitors, and linkages, or referral systems and resources in place. She added that evaluations will include interviews and feedback from home visitors. For more details, please access the MACP update slides.

SDOH

Margaret Mullins spoke briefly about Social Determinants of Health (SDOH) referrals for people responding positively to SDOH Screener questions. She encouraged people to provide warm hand-offs for better participation, suggested that both providers and home visiting program workers create lists of their community-based services for the more common SDOH needs since having those resources handy builds trust. She also suggested they have the MT 211 number and findhelp.org link on hand. Finally, the bidirectional referral systems allow provider and CBO to communicate directly, which is the very best action to help a patient navigate services. Currently, the State is building out a resource engine that will be called

Community CONNECT and will be both a resource search and a self-referral platform. The original CONNECT is being updated and will still be called CONNECT.

- One staff member completing Freedom From Smoking adult tobacco cessation program as well as N-O-T program
 - Coordinating spring visit to conduct ONE Step training for HeadStart staff
- Also work with Riverstone Health, Bozeman School District #7, and Browning Schools on asthma educational support and tobacco cessation
