Rulemaking Actions

AMEND

The rule proposed to be amended is as follows, stricken matter interlined, new matter underlined:

37.36.604 FINANCIAL ELIGIBILITY CRITERIA

- (1) Individuals whose annual family income during the 12 months immediately preceding the month of application is less than 250% of the 2023 2025 poverty guidelines published by the U.S. Department of Health and Human Services (HHS) are eligible for a loan of specialized telecommunications equipment based on income. 250% of the HHS 2023 2025 annual poverty guidelines for families of various sizes is specified on the Montana Accessible Communications program website, effective on January 12, 2023 January 15, 2025, which rate is adopted and incorporated here by reference. - (2) There is no asset test to be eligible for a loan of specialized telecommunications equipment.

General Reasonable Necessity Statement

The Department of Public Health and Human Services (department) is proposing an amendment to ARM 37.36.604 to align the requirements for Montana Accessible Communications (MTAC) with the 2025 United States Department of Health and Human Services (HHS) federal poverty level (FPL) index guidelines.

The following describes the purpose and necessity of the proposed rule amendment pertaining to this rule:

ARM 37.36.604

The department is proposing to amend ARM 37.36.604, pertaining to MTAC financial eligibility criteria. The proposed rule sets forth that an individual is eligible for a loan of specialized telecommunications equipment if the individual's annual family income during the 12 months immediately preceding the month of application does not exceed 250% of the United States Department of Health and Human Services (HHS) poverty guidelines for households.

This proposed amendment updates the rule to adopt the 2025 poverty guidelines published by HHS, instead of the 2023 poverty guidelines published by HHS, which this rule currently adopts. The reason for the proposed amendment to adopt the 2025 poverty guidelines published by HHS is to ensure that the annual income necessary to be eligible for a loan of specialized telecommunications equipment is up to date with the current poverty guidelines published by HHS and to appropriately increase access to eligible persons.

During the public comment period, the proposed rates are on the MTAC website as "proposed," until approved and adopted.

Additionally, the link to a copy of the poverty guidelines published by HHS is proposed to be amended to provide a correction to the new, appropriate link.

Small Business Impact

Pursuant to 2-4-111(1)(a), MCA, the department has determined that the rule changes proposed in this notice will not create a significant and direct impact upon small businesses.

Pursuant to 2-4-111(1)(b), MCA, the department has determined that the proposed amendment will slightly increase the number of people eligible for a loan of specialized telecommunications equipment based on income. By the department's estimate, the proposed amendment could entitle four more individuals for a loan of specialized telecommunications equipment based on income.

Documentation of the small business impact analysis is available upon request.
