

Montana Electronic Visit Verification (EVV) Quick Start Guide

Ready to start setting up your organization for Electronic Visit Verification? Use this guide to learn the basics!

Steps to get set up:

1

Register your agency here: [MT DPHHS EVV Self Registration Website](#). You will receive an email with a username and temporary password following a successful registration.

- You will need your Provider Payer ID, EIN, and Zip code to begin.

2

Using your computer and any web browser (Chrome is preferred), log into the Admin Portal by going to [Mobile Caregiver + Admin Login](#) and clicking on EVV Login, and then signing in with your username and temporary password.

3

On the Admin Portal, manually add or import users using the linked guides to set up Caregivers who will be using the EVV mobile app and provide care services for your participants: [Mobile Caregiver+ User Guides](#)

- If you are using an Alternate EVV Vendor, this step would be completed in your Vendor system.

4

On the Admin Portal, your recipients should be automatically imported from MT DPHHS records. Confirm your recipients are available to you.

5

On the Admin Portal, add upcoming scheduled visits if you are using the State provided solution, Mobile Caregiver+.

- If you are using an Alternate EVV Vendor, this step would be completed in your Vendor system.

6

You are set up!

Following the completion of these steps, notify your caregivers to download and complete their registration on the Netsmart's Mobile Caregiver+ EVV mobile application and complete training so the whole team can begin using EVV!
